

ALBRIGHTON PARISH COUNCIL MINUTES OF MEETING 2nd February 2017 at 7.15 pm in the council meeting room

Minutes of the Albrighton Parish Council planning meeting held on Thursday 2nd February 2017 at 7.15 pm in the council meeting room.

PRESENTATION BY MR CHRIS EDWARDS OF SHROPSHIRE COUNCIL ON THE POSSIBLE TRANSFER OF PUBLIC OPEN SPACES FROM SHROPSHIRE COUNCIL TO ALBRIGHTON PARISH COUNCIL.

Mr Chris Edwards went through his briefing paper relating to reduced standards of maintenance to public open spaces and highway verges once a new contract became operational in April 2018. The reductions reflected the serious budgetary constraints currently felt by Shropshire Council although Cllr. Pate was hopeful that if there was government assistance with elderly care the current pressures on budgets might be reduced within a few years. Tenders would be examined by Shropshire Council over the summer months of 2017 and a new contract would be awarded in September 2017. Once this process was complete the costs that might apply to town and parish councils could be calculated and the information shared.

There were three areas of Albrighton that were being considered for transfer – the Abney Avenue play park, the skate board park and the area in front of the Red House although in the latter case this was complicated by a request to provide a small number of car parking spaces for Red House guests.

The Chairman agreed with members that agenda item 8 should be brought forward so that the council could consider a vote in principle with regard to the play park and the skate board park.

Cllr. Beechey proposed that members should agree in principle to the transfer of the Abney Avenue play park and the skate board park in Newhouse Lane from Shropshire Council to Albrighton Parish Council which was seconded by Cllr. Pledger and agreed 6 – 1 with 1 abstention.

4. PROPOSED DOCUMENT FROM SHROPSHIRE COUNCIL TO BUILD A FURTHER 13,000 HOMES BY 2036.

Cllr. Pate stated that the council should not support more housing in Albrighton as the infrastructure of the village would not cope with a significant increase in the number of homes. Parking was a particular problem which would worsen when the extra houses already approved were built in Kingswood Road. Members registered concern about the suggestion from Bovis that a large number of houses should be approved in the land between the nature reserve and the Wyevale garden centre, a proposal that could be revived under this review of provision. Cllr. Beechey said that the Albrighton Place Plan also needed reviewing in order to ensure that the priorities already agreed for local development were still appropriate

Cllr. Pate proposed that the council should write to Shropshire Council stating that they would be updating the Neighbourhood Plan Light and reviewing the current Place Plan but that there should be no further development in the village. Cllr. Beechey seconded the proposal which was unanimously agreed by the council.

The clerk was instructed to write to Shropshire Council informing them of the council's views.

5. NEW CONTRACTS OF EMPLOYMENT FOR APPROVAL FOR THE LIBRARY ASSISTANT, FLYER DRIVER AND ADMIN ASSISTANT.

Cllr. Pate enquired whether the draft contracts had been shown to the current employees and felt that their views should be obtained. This had not been done except in the case of the Administrative Assistant.

Cllr. Kirkland proposed that the contracts should be approved by council and signed by the appropriate employees which was seconded by Cllr. Pledger and agreed by council 4-1 with 2 abstentions.

6. TO CONSIDER THE PURCHASE OF ADDITIONAL PLANTERS TO THOSE ALREADY AGREED – Cllr. Pledger.

Cllr. Pledger said that the agreed planters had now been ordered but there was still a balance of £3,000 in the budget for 2016/17 for additional arrangements if council wished. Cllr. Straney still had misgivings about the proposals and Cllr. Pate urged members to take a considered look at the whole

village layout and decide what was needed to enhance the appearance before ordering extra items, rather than adding arrangements on an ad hoc basis. Members could be invited to submit ideas and a whole scheme considered in March.

Cllr. Pate proposed that the current balance, together with the 2017/18 budget, should be used to fund an enhancement scheme to be considered at the business meeting in March 2017. Cllr. Straney seconded the motion which was agreed by council 6-1 with 1 abstention.

7. TO CONSIDER A PROPOSAL IN PRINCIPLE TO THE TRANSFER OF THE ABNEY AVENUE PLAY PARK AND THE SKATEBOARD PARK TO THE PARISH COUNCIL IN APRIL 2018.

This agenda item had already been considered at the end of the presentation by Mr Chris Edwards.
