Beechey proposed that the application should be opposed which was seconded by Cllr. Pledger but the vote was tied 3-3. Cllr. Harrison as chairman used his casting vote to support the view that planning application 16/02614/FUL should be rejected.

0004. REPORT BY THE CLERK ON DISCUSSIONS WITH THE CHAIRMAN OF THE SWIMMING CLUB REGARDING INSURANCE FOR THE 2016 SEASON

The clerk informed members that the swimming club had asked for help in paying their insurance bill for 2016/17. The essential details were outlined and Cllr. Hassall's suggestion that the council should not make a contribution led to a general discussion on the funding of the pool at Albrighton Primary School. Cllr. Straney reminded members that the council had given an assurance to the club and the school that it would make funding available for the 2016 season up to a maximum of £9,000 and as a consequence the bill should be paid. He proposed that the insurance account should be paid in full by the council which was seconded by Cllr. Woodman and agreed by council 6-1.

The clerk asked for permission to pay similar bills for swimming pool maintenance and repair received from the school which had been put into abeyance for over a month. Members regretted that there was no central organisation to control spending but Cllr. Straney again urged members to honour the council's commitment to support the swimming pool in 2016. Cllr. Pledger proposed that the bills should be paid and a meeting sought with the school and the swimming club to consider future management of the facility. The motion was seconded by Cllr. Straney and unanimously agreed by council.

0005. TO AGREE ON THE PLACEMENT OF THE THREE BENCHES AT SITES AROUND THE VILLAGE.

The clerk outlined the previous suggestions that new benches should be placed by the post office, at the junction of Shaw Lane and the High Street and at the junction of Abney Avenue and Church Road which was supported by members. Cllr. Beechey proposed that the new benches should be placed at these locations but there was no seconder for the motion.

Cllr. Pledger proposed that the new benches should be placed in prominent positions in the central location in place of existing benches and the old versions should be located at the new sites. The motion was seconded by Cllr. Woodman and unanimously agreed by council. Each of the new

benches would have a plaque fitted in relation to either the great war, the Queen's birthday or the Queen's diamond jubilee. Suggested wording would be circulated later.

0006. TO AGREE ARRANGEMENTS FOR THE SITING AND THE CHOICE OF PLANTERS.

Members discussed which type of planter to purchase and how they were to be maintained. Cllr. Beechey suggested that the clerk should provide further details of possible types of planters and companies such as Wyevale should be approached for sponsorship regarding maintenance. This item was deferred until further details could be provided and enquiries were completed.

0007. TO DISCUSS THE ADDITION OF BOLLARDS IN FRONT OF THE LIBRARY TO SAFEGUARD THE OFFICE AND DISCOURAGE UNOFFICIAL PARKING.

Cllr. Pledger suggested that bollards should be placed in front of the library building to provide protection for the frontage and collapsible bollards placed by the pavement to prevent casual parking. Cllr. Hassall said that some local CCTV might be considered as an alternative and several members expressed their reservations about the suggestion which would require a considerable investment.

Cllr. Pledger proposed that bollards should be purchased to provide protection for the front of the building but there was no seconder for the motion.
