ALBRIGHTON PARISH COUNCIL MINUTES OF PLANNING MEETING Thursday 5th May 2016 at 8.15 pm in St Mary's Church Hall

Minutes of the Albrighton Parish Council planning meeting held on Thursday 5th May 2016 in St Mary's Church Hall.

PUBLIC SESSION:

Four members of the public were present.

Two members of the public raised concerns about the additional parking in the area of the railway station that could result if the application for a drinking establishment at the station (16/01644/FUL) gained approval. The area was already congested with commuter cars parked in the area and this would add to the problem.

Cllr. Woodman reported that there had been no funding to support the station building which had become increasingly dilapidated although it still had a restaurant licence in place. Network Rail supported that application although it acknowledged that the issue of parking was a problem but the proposals for the development on the white land adjacent did contain parking for the station which would alleviate the problem once it was available. He felt that it was appropriate to take the longer term view and that this was an opportunity to put a surplus building to good use and recommended approval for the application. The motion was seconded by Cllr. Illes and agreed by council 7 – 1.

4. TO DISCUSS THE POSSIBLE PURCHASE OF A BENCH OR BENCHES TO CELEBRATE THE QUEEN'S 90^{TH} BIRTHDAY.

Cllr. Pledger reminded council that it had decided in earlier meetings to purchase benches for the Queens diamond jubilee but to date they had not been ordered. She proposed that three benches be purchased by the council to take account of earlier agreements and the forthcoming Queen's birthday. The proposal was seconded by Cllr. Griffin and agreed by council 7-0 with 1 abstention.

Given the earlier decision Cllr. Illes proposed that the appropriate bench would be the Blackburn Anti-vandal seat although Cllr. Hassall did point out that the arms on the proposed bench were placed in a low position. The proposal was seconded by Cllr. Beechey and agreed by council 7-1.

Cllr. Roseby suggested that Cllr. Straney should be asked to produce plaques for each bench and he volunteered to secure the benches in the approved locations once they were delivered.

TO DISCUSS A REQUEST FOR THE PLANTING OF FIVE RAMBLING ROSES AT THE WAR MEMORIAL.

Members were informed that Mr M Jones had made an offer to provide 5 rambling roses around the war memorial and he was seeking council approval. Councillors extended their thanks to Mr Jones for the kind offer which had been approved in principle by the Village Warden and agreed to accept the offer. In addition, members also decided to add 5 rambling roses of their own so that 10 roses would be planted around the memorial taking care that the varieties selected would flourish in a shaded environment.

5. SHROPSHIRE COUNCIL AGREEMENT ON THE SITING OF PLANTERS ON GRASS VERGES.

Members were in agreement that Shropshire Council would need to give their approval for the siting of planters purchased by the council.

6. TO DISCUSS THE POSSIBILITY OF THE PURCHASE OF LAND FROM SHROPSHIRE COUNCIL IN FRONT OF THE RED HOUSE TO ADD TO THE VILLAGE GREENS.

Cllr. Pledger proposed that the council should offer to buy or take over the responsibility for the grassed area in front of the Red House in order to control the use of banners in the trees and generally maintain the area to a higher standard. The proposal was seconded by Cllr. Griffin and unanimously approved by council.
